

TEMPORARY TENT APPLICATION REQUIREMENTS

- Provide 2 completed applications, signed and notarized
- Provide 3 surveys with setbacks and distance to all structures/parking and walkways
- Provide 3 sets of plans** include flame spread ratings
- Provide dates and approximate time tent(s) will be used
- Provide insurance, Worker's Compensation, Disability and Liability for all contractors (I.E. Installer and Electrician) ([Insurance requirements](#))
- Fee of \$200

Weekend inspections will require overtime pay – a minimum of two (2) hours

ADDITIONAL INFORMATION

- As per Section 2403.7.2 of the NYS Fire Code
Location: Tents, canopies or membrane structure shall not be located within 20 feet (6096 mm) of lot lines, buildings, other tents, canopies or membrane structures, parked vehicles or internal combustion engines. For the purpose of determining required distance, support ropes and guy wires shall be considered as part of the temporary membrane structure or canopy.

Exceptions:

1. Separation distance between membrane structures, tents and canopies not used for cooking is not required when the aggregate floor area does not exceed 15,000 square feet (1394m²).
 2. Membrane structures, tents or canopies need not be separated from buildings when all of the following conditions are met.
 - 2.1. The aggregate floor area of the membrane structure, tent or canopy shall not exceed 10,000 square feet (929m²)
 - 2.2. The aggregate floor area of the building and membrane structure, tent or canopy shall not exceed the allowable floor area including increases as indicated in the Building Code of New York State
 - 2.3. Required means of egress provisions are provided for both the building and the membrane structure, tent or canopy, including travel distances
 - 2.4. Fire apparatus access roads are provided in accordance with Section 503
- **As per section 273-1 of the Town of Smithtown Code- Plans shall be provided. Plans shall be drawn to scale, showing exits, aisles, seating arrangements and details of structure, support of tents, seats, platforms, etc.

- As Per section 273-2 of the Town of Smithtown Code -Firewatchers required. One or more qualified persons to serve as firewatchers shall be employed by all circuses, carnivals or other exhibitions where large crowds assemble. They shall familiarize themselves with all fire-protection facilities and fire prevention features and with the condition of exits and shall patrol the entire tent area during the time of occupancy. They shall see that the aisles and exit ways are kept open and that no smoking rules are enforced
- Plans shall also show compliance with Section 2403 and 2404 of the NYS Fire Code and chapter 273 of the Town of Smithtown. *Codes available online or you may request a copy.*

Note: The Department of Public Safety Fire Marshal will also be performing a plan review and may require additional items for compliance with the NYS Building Code and Town of Smithtown Code.
