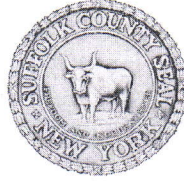

REQUEST FOR WRITTEN COMMENTS ON PROPOSED SHELLFISH AQUACULTURE LEASE ASSIGNMENTS

Notice is hereby given that the Suffolk County Department of Economic Development & Planning has received three Lease Assignment Applications requesting the transfer of three Shellfish Aquaculture Leases in Peconic Bay pursuant to Local Law 25-2009, *A Local Law Establishing the Suffolk County Shellfish Aquaculture Lease Program in Peconic Bay and Gardiners Bay* (Article II of the Suffolk County Code, §475). All lease sites are located within the adopted Shellfish Cultivation Zone and are currently being leased.

Pertinent data and information on each Lease Assignment Application, including the name of the current leaseholder, the name of the proposed assignee(s), respective SCALP # and the location (center point coordinates or SC Tax Map Number) of the lease site are contained in Attachment A of this Public Notice.
